RCC Aim: To combat rural isolation and loneliness throughout Suffolk by visiting rural locations and holding events that act as a catalyst for people to talk with one another in a friendly and non-threatening atmosphere and provide access to services to individuals and communities.

2019: Summary of achievements: What we did....

we welcomed 6268 visitors

we made 292 visits

we visited 90 villages across all Local Authorities

.....and we worked with 69 Organisations

we exchanged 42 pairs of slippers and replaced 157 walking stick ferrules

we held 1 Golden Age Fair and 8 Energy Advice Cafes

we welcomed around 500 visitors at the Suffolk Show and over 100 at Euston Rural Pastimes

we maintained contact with Big Lunch Extras; attended an Outreach Camp in Ipswich

and supported 3 "Big Lunches". We attracted 4,200 followers on Twitter

during the year we had over 106 volunteers active in delivering our service, volunteering a total of 1897 hours

we continued with the development of a network of pubs and cafes holding free coffee mornings called MeetUpMondays. At the year-end we had 60 local locations engaged with the initiative and 30 more nationwide

we involved 20 non-related businesses in MeetUpMondays by inviting them to offer sponsorship in the way of swing-signs and promotional material.

Main Activities

The Rural Coffee Caravan (RCC) exists to tackle loneliness and isolation in rural Suffolk. In Suffolk 40% of people live in rural areas and 51% of households in villages have no access to a regular bus service. There is no fast broadband service to 24% of rural households. The RCC's vision is that all people in rural Suffolk have the connections and community they need to be happy and healthy. In 2019 we continued our efforts to tackle loneliness in the



county in three main ways, bringing people together; signposting people to help; and support and catalysing community initiatives.

The Golden Age Fair in Needham Market on 24th May was attended by 31 different support agencies, a shop selling recycled items, and three different craft activities. The East of England Coop provided and served afternoon tea. We had 161 visitors

come to see the stands, discuss worries or problems or just to ask questions. They had the opportunity to have health checks, take part in activities and enjoy the tea.

Following the award from the Big Lotteries Building Connections Fund we were able during the year to increase the number of village visits to 292 (169 in 2018). We were again present at both the Suffolk Show and Euston Rural Pastimes as well as at the Suffolk Community Foundation's flagship events "Suffolk Dog Day" and the "Woofers Walk".

We were funded by East Suffolk Council's Warm Homes initiative to deliver energy advice and signposting help to rural communities to help people stay warm in their homes throughout winter. We held eight large "Energy Events" from October to December in village locations throughout the county.

The continuing increase in competition for funding has not changed, and throughout the year we maintained our focus on fundraising. As in previous years we worked with a professional fundraiser to supplement our own efforts. We continued to pursue new fundraising opportunities as well as continuing to work with existing funders to ensure, wherever possible, we were awarded repeat funding.

The Queen's Award for Volunteering was presented to us by Suffolk Lord Lieutenant Clare Countess of Euston at an event held in Felstead (courtesy of Judith Shallow). Over 100 volunteers, guests, friends and family attended the event, and we were privileged to have harpist Xenia Horne playing to us throughout the afternoon.



In 2019 we were the only charity awarded this honour.

In the summer, the first ever Suffolk Medal presentation took place. This medal has been commissioned by 2018 High Sheriff George Vesty to recognise exceptional service to the county and we are proud to say that our founder Cannon Sally Fogden was the first ever recipient.

Our CEO was awarded an 'Inspirational Leader Award" by 2018-19 High Sheriff George Vestey

We continued to grow our "MeetupMondays" network of pubs and cafes expanding the numbers of venues involved to 60 in Suffolk and another 30 beyond. These sessions have proven an absolute lifeline for many of the people who join in. Our visits to see how they are doing have always yielded stories of lives being greatly improved by this 'real life' connection. Publicans and café owners have also reported enjoying the sessions immensely and actually experiencing a growth in business as their new friends return at other times as paying customers. We will continue to grow this network and expand into areas of Suffolk as yet without one.

We continued to increase our effective use of social media. As previously, we took part in focussed Twitter events that raise awareness of our work and allowed us to learn of the work of others that may be of interest and could inform us of future activities. As in previous years we continued with our collaborative policy remaining committed to working in partnership with organisations across all relevant sectors to tackle loneliness and isolation.

In 2019 our volunteers continued to deliver fantastic support, and a great contribution, to our work. We had 106 volunteers providing us with a total of 1,897 hours of their time. Our volunteers are dedicated, enthusiastic and passionate and we are incredibly fortunate to have such willing and exceedingly good-humoured people displaying their diverse skills. Their

competencies in such things as towing, baking, insurance, accounting, health and safety, marketing, social media and tea making are essential; and we simply could not function without them.

As in previous years special thanks to CoffeeLink of Ipswich who so kindly donate their fantastic coffee; and East of England Co-op who provide us with great support, endless boxes of tea and invaluable help at our bigger events. We thank them all, such truly fantastic people and organisations!

In 2019 no payments were made to any of the Trustees other than receipted expenses incurred whilst carrying out their duties for RCC.

During the year the charity Trustees have given consideration to the major risks to which the charity is exposed and satisfied themselves that systems or procedures are established to manage those risks. During the year Trustees started to develop plans to strengthen the governing board and will confirm the appointment in 2020 of Iona Lawrence who previously set up the Jo Cox Foundation in 2016 and has worked for The Cares Family more recently.

The Year Ahead

In 2020 we will continue to reach those who are experiencing loneliness, or are at the risk of experiencing loneliness. We will achieve this by creating social spaces in rural places with visits and events, providing tea, coffee, cake, information and the opportunity to chat.

Our Building Connections grant has just over another year to run and we will continue to grow the number of villages we visit and people we meet. This will be coupled with our Rural Energy Work and we plan to hold further energy focussed events in 2020.

We will continue to focus on our core deliverables and embed our new activities as we face the "normal" challenges with funding. We must maintain our efforts to retain and attract funders as we remain committed to the delivery of a service to communities throughout Suffolk. We will remain committed to delivering our objectives of tackling rural isolation and loneliness and promoting community spirit throughout the county. We will continue to create an environment in which visitors and support organisations feel a sense of trust, safety and neutrality; and provide a balanced mix of services and events to meet the needs of different communities.

During the year we will recruit and train new staff, purchase new assets, review processes, enhance collection of data and outcomes information whilst we continue to plan and organise for the certainty that the fundraising environment on which we are financially reliant will remain very challenging.

We will continue to ensure we are positioned as a vital part of the voluntary and "not for profit sector" infrastructure in Suffolk, continuing to help Local Authorities and Organisations to serve and to deliver their work to people in rural communities.

During 2020 at all times we will continue to control costs.

Specifically, in 2020, we will:

- Ensure we continue to concentrate on village visits.
- Deliver the "Building Connections" requirements as per the service level agreement.
- Continue to work with East Suffolk Council on their requirements for the delivery of rural energy work.
- Explore all fundraising opportunities to find alternative sources of funding to cover core costs.
- Launch and develop a new initiative called "More than a Shop" aimed at providing community meeting and socialising space in village shops.
- Maintain relationships with local authorities and organisations and encourage representatives from local councils and voluntary organisations to accompany us on visits and take part in our events.
- Continue to be an enabler for Local Authorities to deliver more effective services to their customers. We will work with them and be recognised as an effective and respected outsourced service provider.
- Work with Suffolk CC and IES CCG on their "Community Connectors" scheme which is a social prescribing initiative initially in the north Framlingham area.
- Continue with the development our "MeetupMondays" initiative. We will enhance the
 provision of the support and network management we offer to participating venues and
 ensure the work receives maximum publicity.
- Continue working alongside Healthwatch including on their "Time for Change" project using our new- found filming skills to capture feedback and impact.
- Continue our excellent relationship with the East of England Co-op.
- Ensure we take every opportunity to increase our pool of volunteers.
- Ensure that throughout the year we work within budget and cash flow requirements at all times.

Financial Reserves

The RCC has a documented Financial Reserves policy designed to minimise the effects of unforeseen circumstances and ensure we can continue to deliver our services. The policy is designed to ensure we can provide sufficient working capital to deal with the circumstances in a professional and organised manner.

The amount of unrestricted funds held as reserves at the end of 2019, was £65,781 which reflects 4.8 months predicted budgeted spend in 2020

This amount is compliant with Reserves Policy (4-6 months) and Trustees have agreed that this is acceptable as a reserve and no specific actions are required.
